Minutes of Public Meeting March 27, 2017

On March 27, 2017 at 7:00 pm, the Derry Conservation Commission met in the 3rd floor meeting room of the Derry Municipal Center.

Acceptance of Minutes:

Paul Dionne made a motion to accept the minutes of February 27, 2017. Margie Ives seconded the motion. Peg Kinsella and Paul Dionne abstained. All others were in favor. Motion carried.

Chair's Report, Correspondence & Bills:

The South East Land Trust has sent a notice to DCC that they will be conducting a 2017 monitoring of the Shepard conservation easement by evaluating recent aerial photos of the land and they will be conducting site visits on Caras and Corneliusen conservation easements. DCC will be contacted in advance for scheduling.

128 Chases Grove – Tax Map 4 Lot 91 – There was missing information on the original application. More information is needed.

Drought update:
