Minutes of Public Meeting February 10, 2014

On February 10, 2014 at 7:30 pm, the Derry Conservation Commission met in the 3rd floor meeting room of the Derry Municipal Center.

The following members were present: Ric Buzzanga, Paul Dionne, Paul Doolittle, Beverly Ferrante, Margaret Ives, Chair, Richard Tripp and Dennis Wiley.

Jim Arruda, James Degnan Peg Kinsella & Marianne Page were absent. Richard Tripp sat for Jim Arruda.

Paul Dionne made a motion to accept the minutes of January 23, 2014. Paul Doolittle seconded the motion. All were in favor. Motion carried.

Chair's Report & Correspondence:

The Barry 4-H camp is a 35 week program for ages 10-16 featuring fishing, wood crafting, hunting education etc. The cost to sponsor a child is \$485.00 a week. Dennis Wiley made a motion to pay \$200.00 to help sponsor a child to attend the program, hopefully a Derry child if available. Paul Dionne seconded the motion. All were in favor. Motion carried. The money will be taken from the Administrative Account. A Derry applicant is preferred but not required.

The Gift of the Collette's Mountain property was accepted by the Town Council at their last meeting. The property borders the Town of Hampstead Conservation Land. This year's walk could be a combination of the two town conservation properties.

An older list of DCC land criteria had been handed out and updated this evening. With keeping these criteria in mind such as wildlife corridor, agricultural soils, wetlands, etc. and after discussion on the property list, the commission decided on looking into the Hunter Dr. property, Orchard Dr. and the Goodhue Rd property. Chair will get more info on these properties for future discussion.

Update on Conservation activities:

The Snowshoe event at Broadview Farm last weekend went well. Over 50 people were in attendance. There was plenty of snow this year and lots of sunshine. Chair gave thanks to Go Green for such a fantastic event.

Japanese Knotweed:

Richard Tripp has completed the brochure he created. There was discussion of putting the brochure on the Derry website.

Goals & Objectives:

The goals & objectives list was discussed at the previous DCC meeting. Changes & additions were made. Chair presented the updated version tonight for review before handing it over to Mike Fairbanks, Council Chair.
