Supervisor Dowling motioned to accept proof of domicile. Supervisor Dombroski seconded the motion. The motioned carried 3 – 0. The voter's domicile in Derry is verified. No further action is required.

All Supervisors registered eligible students from Derry at Pinkerton Academy on January 9. Supervisors from Chester, Hampstead, and Hooksett registration. The new voters are enthusiastic about participating in the First-in-the-Nation presidential primary on January 23.

Supervisors Dombroski and Strakalaitis attended Secretary of State election law training in Atkinson on January 11. Information was shared with Supervisor Dowling.

The final training class for Assistant Supervisors of the Checklist is tomorrow, January 17.

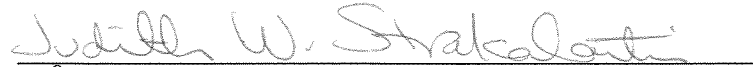

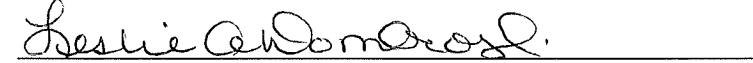

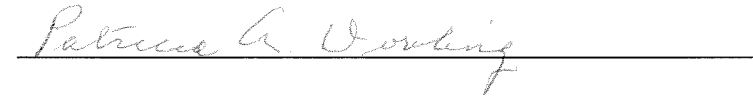
