Unofficial Reports

The Supervisors of the Checklist considered reports indicating a voter on the Derry checklist may no longer be domiciled at the address on the checklist. Supervisors determined which reports were actionable under RSA 654:36-a.

Supervisor Dombroski made a motion to initiate the removal process for voters on **List E** under RSA 654:36-a. Supervisor Dowling seconded the motion. Motion passed unanimously.

Supervisors mailed notification to each voter on List E informing them they must verify their domicile within 30 days or be removed from the checklist at the next session.
