NARRATIVE

The Town of Derry funds a part-time Health Officer and a part-time administrative assistant. These positions support inspections of food service establishments and commercial and residential properties for health-related matters.

Additionally, the Town of Derry serves as the fiscal agent for the grant-funded Greater Derry Public Health Network. The purpose of these grants is to demonstrate capacity to build regional public health services by collaborating in regional public health emergency preparedness and response activities.

PROGRAMS AND ACTIVITIES

Food Service Inspections

The Town of Derry has over 150 food service establishments. These include: restaurants, ice cream parlors, supermarkets, convenience stores, schools, day cares that serve food, nursing homes and a hospital. The Health Officer conducts routine inspections and responds to complaints regarding food establishments.

Commercial and Residential Inspections

The Health Officer conducts inspections in response to complaints of health violations in commercial and residential buildings such as: squalor conditions, vermin and insect infestations, inadequate heat or hot water in rental units, and nuisance complaints (trash or junk accumulating on private property). The Health Officer also conducts all Day Care and Foster Care routine and complaint inspections for the Town of Derry as required by the State of New Hampshire.

Mosquito Control Program

The Health Department oversees the planning and implementation of the Town's Mosquito Control and Public Education Program. This program seeks to reduce human infection from mosquito borne illness through public education and reduction of mosquito population. In the Fall of 2009, the Health Department successfully utilized this program following positive tests of mosquito pools in Derry for Eastern Equine Encephalitis (EEE). This program is funded through a combination of Town and School allocations, as well as State reimbursements.

Regional Public Health Emergency Planning & Response

The Public Health Network Coordinator facilitates regional public health emergency planning with a current emphasis on emergency mass dispensing planning and response. During fiscal 2010, grant-funded personnel planned and conducted over twenty H1N1 flu vaccination clinics that provided nearly 3000 free vaccinations across the region. **Medical Reserve Corps**

The Public Health Network Coordinator directs activities of the Greater Derry Medical Reserve Corps (MRC). The Greater Derry MRC is comprised of medical and support volunteers who assist in responding to local and regional health emergencies. During the H1N1 response, Greater Derry MRC volunteers donated over 200 hours of service to support clinic operations.
