#### Town Administrator's Report - David Caron

Frank R. Biron, CPA, Principal and Zackary Fentross, CPA, Audit Manager from Melanson Heath presented the audit report for the year ended on June 30, 2019. Melanson Heath did not discover any deficiencies in internal control that they consider to be material weakness. There may be material weakness that has not been identified. Melanson Heaths recommendations include Ensuring Compliance with Uniform Guidelines, Preparing for GASB Statements 84 and 87, and Expanding the Chart of Accounts.

Accounting Manager Mark Fleischer presented the First Quarter Financial Report prepared by CFO Susan Hickey. September 30<sup>th</sup> is 25% through the fiscal year. General Fund revenue and expenditures are at 19% and 31% respectively. Cable revenue and expenditures are at 0% and 16% respectively. Water revenue and expenditures are at 1% and 182% (due to Southern NH Regional Water Interconnection project) respectively. Wastewater revenue and expenditures are at 4% and 21% respectively.

### RESOLUTION

### Number 2019-056A

Final Order on a Town Charter Amendment Vote Relative to Section 9.4(A) Limitation of Budget Increases (Tax Cap)

WHEREAS, Section 5.1 of the Town Charter establishes the Town Council as the governing and legislative body of the Town, thereby empowering the Council to implement laws as may be enacted by the State Legislature; and

WHEREAS, the voters of the Town enacted Section 9.4 (A) of the Town Charter which places a limitation on the annual increase to the town tax rate; and

WHEREAS, although voters did approve specific exceptions to the tax cap in subsections (A) & (B) of Section 9.4, the Supreme Court recently ruled in a case involving the City of Nashua that a general override of the tax cap pursuant to RSA 49-D:3 I (e) shall be included in a Town Charter in order to maintain the validity of a Tax Cap; and

WHEREAS, voters have supported the Tax Cap and the Town Council seeks a remedy to maintain the Tax Cap; and

WHEREAS, the Town Council held a public hearing on this matter on October 1, 2019, and recently received confirmation from the Attorney General, Secretary of State and Department of Revenue Administration that no objections are raised on this matter;

NOW, THEREFORE, BE IT RESOLVED IN COUNCIL that a question shall be placed on the Official Ballot of the March 10, 2020 municipal election, worded as follows:

"Shall the Town adopt Section 9.4 (C) of the Town Charter which provides for an override of the tax cap upon a two-thirds vote of the entire Derry Town Council" (Failure to enact this subsection will invalidate the Tax Cap):

(C) Override of Tax Cap: The Council may vote to exceed the limit on annual increases under the tax cap provision in Sec. 9.4 (A) for the specific budget year under consideration upon a two-thirds vote of the entire Derry Town Council.

(This amendment will bring the Charter into compliance with RSA 49-D:3, I, (e) which requires override thresholds for charters containing municipal tax caps. See also Teeboom v. City of Nashua et al. 213 A.3d 877, NH July 2, 2019. The Teeboom case invalidated the City of Nashua's tax cap, which contained nearly identical language to Derry's current tax cap, because it did not include the override provision as required by the statute.)

This Resolution shall take effect immediately upon its passage.
