#### Chairman's Report - Neil Wetherbee

300<sup>th</sup> Anniversary Celebration Closeout Presentation and Time Capsule – *Heritage Commission Chair Karen Blandford-Anderson and Heritage Commission Vice-Chair and Chair of the Nutfield* 300<sup>th</sup> Steering Committee Paul Lindemann

Karen and Paul gave a recap of the past year's Nutfield 300<sup>th</sup> events. The new time capsule will be locked up in an old vault in the Derry History Museum at the Adams Memorial Building and will be opened for the Nutfield 350<sup>th</sup>.

#### Town Administrator's Report – David Caron

The draft results of the recreation study will be presented at the 2<sup>nd</sup> Town Council meeting in January. The TIF Advisory Board will meet after the 1<sup>st</sup> of the year. The Town is still working on the Comcast Renewal agreement. The Town is waiting on the Louise Way petitioners to notify

the mortgagees before a public hearing can be scheduled. The Town received a Community Development Block grant for \$290,000 on behalf of the Derry Housing and Redevelopment Authority and a grant admin will be on board by mid-January.

### Public Hearings -

**19-135** Ordinance #2019-014 – Authorization to post temporary parking restrictions – *Police Chief Ed Garone* 

Occasionally, traffic conditions may manifest that require the prompt establishment of temporary alteration or limits on existing parking regulations as codified in Chapter 150-3 for the benefit of public safety. In accordance with the Town Charter, the Town Council is responsible for adopting or amending town ordinances. There is currently no mechanism that allows for an immediate or temporary change to parking regulations as established by ordinance. Amend the current Traffic Ordinance, Chapter 150-3, Temporary Parking Restrictions, by adding a new Section C. that adds the following language: "The Chief of Police may, for the purpose to address temporary or unanticipated traffic conditions, post "Official traffic Signage" to limit or alter parking regulations set forth herein for a period of not more than 60 consecutive days without further Council approval."

#### New Business -

**19-141** Resolution #2019-070 – Apply for and accept funding from the Walmart Community Grant Program – *Police Chief Ed Garone* 

Recently Walmart managers contacted both the Police Department and the Fire Department and advised that they would like to provide a grant of \$2,000 to each department as part of their Community Grant Program. The funds come without restriction on use. In order to electronically apply for the funds, a document must be provided asserting, among other things, that the applicant has authority to apply for the funding. The Town Charter designates that the Town Council may apply for and accept grants or gifts. Specifically, "SECTION 9.15 Grants, Gifts; provides in part, that the Town Council may apply for, accept and expend monies received from the State, Federal, or other governmental units, or from private sources which become available during the fiscal year." The Police Department plans to utilize its portion of the funds to purchase two ballistic shields requiring replacement. The Fire Department will expend the grant on Fire Prevention supplies. As the grant is less than \$10,000, no public hearing is required pursuant to RSA 31:95-b.

### **ORDINANCE**

### Number 2019-014

### Amendment to Traffic Ordinance, Section 150-3 Temporary Parking Restrictions

WHEREAS, Section 5.1 of the Town Charter vests in the Town Council the powers of the legislative and governing bodies; and

WHEREAS, the Town Council is responsible for adopting and amending town ordinances; and

WHEREAS, the Town requires a mechanism to address parking conditions on an immediate and/or temporary basis; and,

WHEREAS, public safety will be enhanced through this action;

NOW, THEREFORE, BE IT RESOLVED IN COUNCIL that the Town's Traffic Ordinance, Section 150-3, Prohibited Parking, is hereby amended to add the following:

New Section C. – The Chief of Police may, for the purpose to address temporary or unanticipated traffic conditions, post "Official traffic signage" to limit or alter parking regulations set forth herein for a period of not more than 60 consecutive days without further Council approval.

This Resolution shall take effect 30 days after its passage.

### RESOLUTION

### Number 2019-071

To Accept and Expend Funding from FEMA

WHEREAS, the Section 9.15 of the Town Charter authorizes the Town Council to apply for, accept and expend funds received from the State; and

## **ORDINANCE**

## Number 2020-001

### Amend Various Articles in the Zoning Ordinance to allow

Sports	Betting	Retail	Locations

WHEREAS, Section 5.1 of the Town Charter designates the Town Council as the governing and legislative body of the Town, and pursuant to Section 6.1, the Council shall legislate by ordinance; and
WHEREAS, the State Legislature authorized up to ten sports betting retail locations throughout the State, and
WHEREAS, the Legislature further requires local approval to allow vendors to offer sports betting retail within the community; and
WHEREAS, the Planning Board has held the requisite public hearing and voted to recommend this amendment to the Town Council;
NOW, THEREFORE, THE TOWN OF DERRY ORDAINS that the Derry Zoning Ordinance is hereby amended as follows:
To AMEND Article II, Word Usage and Definitions, Section 165-5, Definitions, to add definitions relating to Sports Wagering, and to AMEND Article IV, District, Section 165-32, General Commercial IV, and Section 165-42, Industrial IV District to amend the list of permitted uses.
This Ordinance shall take effect thirty days after its adoption.
