Chairman Report - Charles Foote

Derry Housing and Redevelopment Authority – *Chair Ernie St. Pierre presenting*The DHRA administers 111 Section 8 Housing Choice Vouchers, that is 3 more vouchers from last year. DHRA recently sold 12 Peabody Road on 11/23/23 to Family Promise. They will provide transitional Housing to families in need. DHRA's waitlist for Section 8 assistance has approximately 174 applicants at this time. There is currently one vacant spot on the DHRA Board of Commissioners. This spot is for a tenant representative of the Section 8 Housing Choice Voucher Program.

Conservation Commission – *Vice Chair Rick Buzzanga presenting*Conservation Commission has been working closely with the TRC program as a stakeholder to be advocates of the watershed. We have also been working on Conservation easements with wetland impacts. Broadview Farm is doing well, Will does a great job managing that.

Volunteerism is down, we need to get that back up. For the next year, we are looking to partner with DPW as a permanent solution to trail maintenance and continue to review signage needs.

Legislative Task Force – Chair (Councilor) Jim MacEachern presenting
The Task Force is comprised of 3 Town Councilors, 3 School Board Members, 3 State
Representatives and our State Senator. The Town, School and State share information about upcoming legislation and the effects on the Town/School District in Derry and the Town and School share various projects and future plans. An exchange of information and ideas so everyone knows what is going on.

Town Administrator's Report - Dave Caron

With the resignation of our Fire Chief, there is a position to fill. I am requesting confirmation of the appointment of Shawn Haggart as Derry's new Fire Chief.

24-12 Resolution #2024-012 – To Confirm the Appointment of the Fire Chief – Dave Caron presenting

FY25 Capital Improvements Plan is attached here and will be presented tomorrow, February 21, to the Planning Board.

SB589 has been drafted and is awaiting a hearing before the Senate Energy and Natural Resources Committee. This bill would enable municipalities to place a surcharge (max 15%) on out of town wastewater customers to recognize the investment made into the Town's utilities by Derry residents which allows the Town to share these services.

Central Fire Station construction manager anticipates receiving bids on all remaining work by March 14.

The Director of Public Works participated in a meeting with NHDOT in preparation for bidding Contract B of Exit 4A. We anticipate requesting authorization to enter into a contract with an engineering firm (paid by NHDOT) to assist with utility relocation and design. The \$31M is scheduled for a May advertisement.

New Business

24-14 Resolution #2024-008 – Approve and fund a Collective Bargaining Agreement with the Derry Police Patrolman's Association – *Town*

The Derry Police Patrolman's Association represents 44 Officers in the Derry Police Department. This agreement is a 3 year agreement to June 30, 2027. It provides for a market adjustment and a 3% COLA.

Number 2024-008

To Approve and Fund a Collective Bargaining Agreement with the Derry Police Patrolman's Association

WHEREAS, Section 5.1 of the Town Charter establishes the Town Council as the governing and legislative body of the Town, thereby empowering the Council to enter into contracts; and

WHEREAS, the Town Administrator, pursuant to Section 8.6 of the Charter, has proposed that the Town enter into a collective bargaining agreement with the Derry Police Patrolman's Association for the period July 1, 2024 through June 30, 2027: and

WHEREAS, pursuant to RSA 273-A, the legislative body must make an appropriation to fund the cost items of a collective bargaining agreement; and

WHEREAS, the cost items of this collective bargaining agreement applicable to Fiscal Year 2025 shall be included in the FY25 budget, and the Council is aware of and acknowledges the future costs of the agreement, which the Town shall be obligated to fund;

NOW, THEREFORE, BE IT RESOLVED IN COUNCIL that the terms, conditions and costs of the "Collective Bargaining Agreement between the Town of Derry and the Derry Police Patrolman's Association for the Period July 1, 2024 through June 30, 2025" are hereby approved;
