Chairman's Report - Joshua Bourdon

Councilor Morgan was a few miles away from the Parkland Florida school shooting and provided his insight on the matter. There were helicopters flying around constantly and news stories daily from people affected. He was amazed by both sides during the forum Marco Rubio held. The problem is concerning, and communities cannot wait for Washington to do something, if they council can help in any way by funding, he would be in favor. The town election is one week from today on Tuesday March 13 from 7 a.m. to 8 p.m. Chairman Bourdon listed a few of the highlights of the past year from this council and then thanked each Councilor individually.

Town Administrator's Report - David Caron

The Economic Development Coordinator Bev Donovan and Town Administrator Dave Caron visited merchants downtown to explain the façade program and had a good number of merchants interested. There are a few public works projects. The bike path design work is currently on going with the project to be bid in June/July and construction starting in late summer with a completion date of October. Several hundred feet of water main is set to be replaced on Fordway with a bid in April, work to begin in May/June and completion by July. The contractors will be returning to Brady Avenue in April to perform water and sewer main installation, project expected to be completed by August 2018. DPW plans to mill and pave a

section of distressed pavement in front of the Crystal Place redevelopment area in September or October 2018. The project will coordinate with the developer utility trench cuts but there is a need to complete the paving no later than October 2018. As of Friday, the Council has received letters of interest from 12 volunteers currently serving on Boards and Commissions.

Public Forum - *30 Minutes* Open Public Forum - all agreed

Mary Till: Old Chester Rd – Town Moderator Mary Till reminded the council that she will be conducting counting of votes at all three polling locations and then tallying the results at the Central Polling place. She asked the town to consider not breaking down the polling places until all the votes are counted because of the noise.

New Business

18-27 Resolution #2018-011 – To Expand the Charge of the Net Zero Task Force Expanding the charge of the Net Zero Task Force was presented by Town Administrator David Caron. The Energy & Environmental Advisory Committee (EEAC) was established by the Town Council in 2009 with its main mission to educate the public on energy conservation measures and energy efficiencies, and to support local initiatives which are consistent with the Mission of the Committee. The Net Zero Task Force (NZTF) was initially created by the Council in 2016, and later designated as a standing committee by the Council in 2017. The Task Force's main missions is to focus on sustainable energy strategies for public buildings. While the EEAC is comprised of community volunteers, the NZTF's membership consists of one volunteer and representatives from many stakeholder groups in the community. As the Committees implement their respective charge, the Town has experienced events whereby both committees may logically take the lead and/or support the other's activities. Municipal efficiencies suggest that these Committees should be merged to provide more synergy and resources for mission-related projects.

The current Ambulance Service Transport contract is set to expire at midnight on June 30, 2018; while the current Fire and EMS dispatch contract is set to expire in two years; this contract- if approved, would supersede the last two years of the existing fire/EMS dispatch contract and extend that contract for an additional 8 years.

To Expand the Charge of the Net Zero Task Force

WHEREAS, Section 5.1 of the Town Charter vests in the Town Council the powers of the legislative and governing bodies; and

WHEREAS, the Town Council previously established an Energy and Environmental Advisory Committee whose mission is to promote energy conservation and energy efficiency; and

WHEREAS, the Town Council also previously established the Net Zero Task Force, whose mission is to explore and achieve cost effective solutions for reduced energy use and sustainable energy development for town-controlled properties; and

WHEREAS, the missions of the two groups are analogous and complementary of each other, and operational efficiencies and effectiveness will be enhanced by combining the two;

NOW, THEREFORE, BE IT RESOLVED IN COUNCIL that the Town Council hereby disbands the Energy and Environmental Advisory Committee as previously established by the Council on August 11, 2009, and amends the By-Laws of the Net Zero Task Force, including a revised mission, goals and membership to reflect the Task Force's expanded responsibilities.

To Extend the Term of Intermunicipal Agreements with the Town of Chester to Supply Emergency Medical and Dispatch Services

WHEREAS, Section 5.1 of the Town Charter designates the Town Council as the governing and legislative body of the Town, and

WHEREAS, the Fire Department has maintained a lengthy relationship with the Town of Chester by providing EMS and Fire Dispatch services; and

WHEREAS, the current agreement to provide EMS services to the Town of Chester is scheduled to expire June 30, 2018; the Dispatch services agreement shall expire June 30, 2020; and Derry and Chester have negotiated ten-year successor agreements which will benefit both parties;

NOW, THEREFORE, BE IT RESOLVED IN COUNCIL that the Town Administrator is hereby authorized to execute Intermunicipal Agreements, developed in accordance with RSA 53-A, between the Towns of Derry and Chester to continue providing Emergency Medical and Dispatch Services through June 30, 2028.
