Congratulations to the winners. We had our elections last week. We had 3218 voters. We had a great turnout. We had a large number of write in votes. A total of 1863 write ins. I would like to thank DPW, the poll workers and the volunteers. The high school kids, the PTA. The School Board and the Councilors. We are thankful for the Police and Fire that stayed with us all day. This is the last report I will give. Thank you to Tina Guilford our former School District Moderator and current Town Clerk. I would like to introduce our new Derry Town Moderator Dave Nelson. It has been a pleasure to serve the Town.

Town Administrator's Report - Dave Caron

Pursuant to a standing directive from the Council, notice is hereby given that the detail rate for police services will be \$91/hour effective July 1, 2024. The rate is calculated based upon the overtime rate of the Master Patrol Officer with all benefits and an administrative fee retained by the Town. The cruiser detail rate will be \$22.91/hour, which mirrors the FEMA reimbursement rate. Most of the footings have been constructed as work continues on the frost walls of the new central Fire Station, along with continuing site work. Work has been bid for the remaining contracts and we should have information on those bids in the next week or so. Staff are looking at the Federal CDS Program as an opportunity to fund an upgrade to the Police Department Records Management and CAD Software programs. The preliminary review of the FY25 draft budget is wrapping up in preparation for presentation to the Council at the April 2 meeting. In partnership with the Town of Londonderry, Household Hazardous Waste Day is scheduled for Saturday, June 8, 9AM-12PM at West Running Brook School. Please visit the Town's website for more information. Although you would not know it by the weather, the winter parking ban remains in effect until April 1st. On the legislative side, SB589 - Wastewater Surcharge bill was recommended OTP 5-0 by Committee with a full Senate vote scheduled March 21. HB1479 the lobbying Bill came out of committee without recommendation and is awaiting full house action.

SB553 the Directive on Town Investments, has passed the Senate and is awaiting a public hearing in the House.

The Derry Fire Department is requesting permission to apply for the Assistance to Fire Fighters Grant through the US Department of Homeland Security. The amount of this grant request is approximately \$156,535 with a 10% cost share. This grant funding would support the purchase of 4 hydraulic cutters, 4 hydraulic spreaders, 2 hydraulic ram kits and one combination cutter/spreader tool. These tools are primarily used for vehicle extrication and our current equipment is older than 20 years.
