Chairman's Report - Neil Wetherbee

The 300th anniversary of Nutfield is approaching. Information can be found on nutfieldhistory.org. Road work has started on By-Pass 28 and the Scobie Pond Intersection with the project going on the majority of the summer. It is an NHDOT project and not with the town. Welcomed the new Fody's Tavern to town. There are plans for a landscaping business to go in at the end of Ashleigh Dr with a 15,800 square foot building. There is a townhouse project starting on Nutfield Court. The over 55 development on Tsienneto Road has started.

Councilor Foote gave an update on the MacGregor Fountain. The Derry Village Rotary Club members installed the refurbished cast iron water fountain in MacGregor Park last weekend.

The fountain will be officially unveiled and dedicated at a ceremony in the park on April 14 at 4 p.m.

Councilor Phyllis Katsakories gave an update on the Boston Post Cane. She stated that Dorothy "Dot" Stone, 99, was presented with the town's Boston Post Cane during a ceremony held at Pleasant Valley Nursing Center. Dot was born in Derry in 1919 and lived in Derry all her life with the exception of eight months. Town Administrator's Report – David Caron

Resolution #2019-010 - To Confirm the Appointment of the Human Resources Director Section 8.6(8) of the Town Charter requires that the Town Council confirm the appointment of officers and employees who report directly to the Town Administrator; and a vacancy exists in the position of Human Resources Director; and after a comprehensive search involving input from various stakeholders and a review of organizational priorities and projects, the Town Administrator has appointed a candidate who possesses the necessary skills and experience to manage the Town's human resources functions and responsibilities. The Town Administrator appoints Lisa Crowley as Human Resources Director.

The towns of Salem and Windham residents have voted to approve receiving water from Manchester Water Works under the Southern New Hampshire Water project and the Intermunicipal Agreement is nearing completion. The document will require Town Council approval and will hopefully be reading for the next meeting but definitely by the first meeting in May. NHDOT recently notified abutters of the proposed route of Exit 4A and the survey work will begin in that area shortly. The request to fly a POW flag on Town property was researched and it has been determined that it is up the Council on what they would like to do. There are Governor funds available for repairs on rail trails and dams and the Town will be following up on trying to secure funds. Speaking to Mr. Trefethen's concerns from the last meeting, Code Enforcement has reached out to the property owner with no response. The Town Administrator does urge residents to notify the Derry Police Department if they suspect anyone of driving under the influence. Town Administrator David Caron and CFO Susan Hickey presented an overview of the proposed FY20 budget. Budget hearings will begin April 9th.

19-21 Ordinance #2019-002 – Relative to Amending the Zoning Ordinance to Amend Article VI, District Provisions in the Central Business and Traditional Overlay Districts to allow Residential Uses Above the First Floor – *Planning Director George Sioras*

Over the last two years both the Derry Town Council and Planning Board worked on their respective goals and requested staff to review the permitted uses in both the Central Business District and Traditional Business Overlay District. This ordinance would amend Article VI, District Provisions, Section 165-33.B.5.b.iii, Central Business District and Section 165-49.B.lb, Traditional Business Overlay District to allow residential use above the first floor. The purpose of the amendment is to allow for the best and highest use of properties and to spur economic development in the downtown. It also will encourage mixed-use development and allow for different housing options in the downtown.

19-28 Resolution 2019-015 – Relative to the Legislative Committee – *Town Administrator David Caron*

The Legislative Committee is to bring together the Town's elected state delegation with representatives of town government and the School District to review, discuss and collaborate on state issues which are important to the Derry community and its taxpayers. Three members of the Deny Town Council appointed by the Chair; Three members of the Deny Cooperative School Board appointed by the School Board or other process as determined by the School Board; Ten State Representatives elected by Derry voters; One State Senator elected by Derry voters. The Town Council shall appoint the Chair of the Committee from among the three Council appointees. The Chair shall preside at all meetings of the Committee when he or she is present and shall direct the work of the Committee. The Chair may appoint chairs of any subcommittees from the membership as approved by the Committee. The chair shall submit a report to the Town Council during the month of January similar to the provisions of Section 4.8 in the Town Charter as required of Standing Committees. The Chair shall set the agenda, send the approved minutes to the Town Clerk and post notices of Task Force meetings and give notice to members when necessary. The Derry Cooperative School Board shall appoint the Vice Chair from among the three School Board appointees and shall assume all duties and powers of the chairperson in his or her absence. The Vice Chair shall assist the Chair in all Committee

planning and activities, including setting the agenda. The Secretary shall keep minutes of all meetings and proceedings of the Committee and record any action taken. The Committee meetings shall be open to the public in accordance with NH RSA 91-A and be held quarterly or more often at the call of the Chair. The time and place of each meeting shall be posted in accordance with these requirements. All meetings will be held in accordance with the Derry Town Charter and will follow Robert's Rules of Order. A quorum shall exist when four of the six Council and/or School Board representatives are present.
