Lee Brolin, Lancelot Drive, Representing the VFW, American Legion and all veterans. Wants to stress to the council how important it is to increase the Veterans credit to the maximum allowable. Derry needs to do more, especially in our current economic climate, to assist those who have served.

Steve Trefethen, North Shore Drive, feels zoning needs to be corrected. Sited the new development happening on Rockingham Road without a good mix of Retail and Housing and that zoning is an issue. Wants the council to watch the store since zoning is not watching our wallets.

Mary Hogan, Danville Resident, speaking as President of the Greater Derry Arts Council inviting the Town to Derry's Got Talent and Derryfest on September 17. Also, there are lots of renovations happening at the Derry Opera House and there is a lot of excitement for the reopening in October.

Tom Cardon, Cunningham Drive, West Running Brook district should have been like Tuscan Village and its not. Keystone development has passed, and it is not phasing in as it should. As they do more projects, they need to stick with the phasing in process. Retail and Commercial is needed along with the housing. Requests a Workshop to understand the zoning.

Chair Report - Joshua Bourdon

Town Clerk Tina Guilford and Town Moderator Lisa Hultgren give an overview of election law changes taking effect for the Primary Election on September 13, 2022. Election will be at Calvary on Hampstead Road from 7AM to 8PM. Election Law updates include a new storage procedure for ballot boxes after the election and a new Purity of Election Law.

Mike Fowler gives an overview of the current veterans' tax credit as applicable in Derry and what is available under new statute. Council will continue to review this issue.

Chairman Bourdon presents a request for a letter to be sent to all the State Representatives running for election showing the Town of Derry's support for the legalization of cannabis in the non-binding question on the Town ballot in March of 2022. Council will review wording and revisit at the next meeting.

Chairman Bourdon presents a request for a letter to be sent to Pinkerton Academy to encourage them to investigate the possible solar options that may be available to the Academy. Council will be reviewing this request at a future meeting.

Committee Status of EDAC – This committee was started when there was a hole that needed to be filled. Residents and business members stepped up and worked on various projects for economic development. The Town has since hired an Economic Development director and at this point this is a committee that has no purpose. The Council will look to sunset this committee at the next meeting.

Town Administrator's Report - Mike Fowler

Pursuant to Article 8 of the Town Charter, the following Resolution is being brought forth. Police Chief Garone has indicated that he will retire effective September 30, 2022. Therefore, a new Police Chief is needed.

Resolution #2022-067 – To Confirm the Appointment of the Police Chief Deputy Chief George Feole has served for 42 years and has the experience needed to lead our Police Department. Town Administrator Caron has appointed Deputy Chief Feole as the next Police Chief of Derry.
