

Request for Proposals-
Chemical Root Control Services
Town of Derry, New Hampshire
Fall 2018
(B-19-118)

The Town of Derry, New Hampshire Department of Public Works is requesting proposals for **the application of licensed root control agents to treat approximately 6,143 linear ft. of main line sanitary sewers** in order to kill root growth present in the lines and to inhibit root regrowth without permanently damaging the vegetation producing the roots. (See appendix for locations)

All Contractors must provide evidence of compliance with all applicable federal and State requirements relative to chemical root treatment including Certification by the State of New Hampshire Pesticide Regulatory Agency as required by law.

Quotes shall include a description of the Chemical Root Control Material & Associated Material Safety Data Sheets and a description of the manner of application.

Contactor shall include with their bid proposal a written narrative that includes:

- a. Description of equipment to be used
- b. Description of application process
- c. List of personnel to be present during treatment
- d. List of chemicals to be used and a copy of their respective MSDS sheet
- e. A list of at least three (3) references for whom similar treatment was conducted
- f. Quote in the following format:

The Responsibilities of the Contractor will include:

Contractors Responsibilities

1. Contractor shall provide all labor, materials, equipment and mobilization for the chemical treatment of the approximate quantity of sewer mains to be treated as specified in this request.
2. Should any chemical root control agent spill on the ground, the Contractor shall remove and safely dispose of the chemical and the affected soil. The Contractor will restore the area to a condition equal to or better than before the spill. Any damage to vegetation resulting from misuse of the chemical root control agent is the responsibility of the Contractor.

3. Contractor shall respect the rights of private property owners, and not enter upon private property without obtaining permission from the owner.
4. Place proper traffic warning devices to protect the specific job site, and to prevent accidents or personal injury to the public. Flagmen for safe traffic control shall be provided as conditions dictate.
5. Keep complete, accurate records of each day's operation. Records shall show date of treatment, sections of line treated, pipe size and distance, and other pertinent information. Log sheets will be submitted with the invoice.
6. Assist in the evaluation of the root control application.
7. Dispose of all pesticide containers, according to the state and federal regulation pertaining thereto.

The Town Shall:

1. Provide a department representative to accompany crew, and/or sewer system drawings showing the exact location of pipes to be treated.
2. Assist and make provisions for the entering upon private lands, public lands and right of ways.
3. Provide fresh water for the purpose of mixing the root control agent and clean-up.
4. Locate any hidden or buried manholes, and restore street surfaces, easements, etc.

Quotes will be evaluated based upon unit price, experience, references and any performance guarantee by the Contractor.
