#### Sale of Town-owned Property

The Town of Derry offers for sale two (2) parcels of Town-owned land. Sealed bids will be accepted until 2:00 p.m. on Thursday December 16<sup>th</sup>, 2021, in the Town Administrator's Office, 14 Manning Street, Derry, NH 03038, at which time they will be opened and publicly read aloud.

The following Town-owned land parcels are being offered for sale:

**Parcel 1:** 5.5 Tracy Drive parcel containing approximately 2.88 acres with GIS ID (map/lot #) 01-015-015. Taxes, interest, penalties, and cost owed to the Town of Derry -\$11,665.29

**Parcel 2:** 30 English Road parcel containing approximately .16 acre with GIS ID (map/lot #) 59-002. Taxes, interest, penalties, and cost owed to the Town of Derry -\$5,826.25.

#### **Conditions of Sale**

- 1. In addition to the bid purchase price, the successful bidder must pay all deed preparation, recording, and legal services regarding the transfer of the property. Additional fees may apply depending upon the parcel that you acquire.
- 2. Separate bid forms are needed for each parcel you bid upon. The required bid form is attached at the end of this Request for Bids.
- 3. All bids must be submitted in a separate sealed envelope for each parcel being bid upon with the following notation on each envelope: <u>Town of Derry, Sale of Town-Owned Land, Parcel #</u>. Bids should be mailed, or hand delivered to the Town of Derry, Attn: Town Administrator/ Request for Bids, 14 Manning Street, Derry, NH 03038 and received no later than 2:00 p.m. on Thursday December 16, 2021.

- 4. You must submit a deposit of \$500.00, in the form of a bank check (i.e. cashier's, certified, or money order), with each bid. If you are not the successful bidder, your deposit will be returned after closing takes place on that parcel.
- 5. If you are the successful bidder, acquisition of the property must be completed by January 31<sup>st</sup>, 2022. At the time of closing on the property acquisition, you will pay any final sums owed to the Town of Derry. If you do not close on the property as required above, you will forfeit the initial bid deposit of \$500.00 and that deposit will become the property of the Town of Derry.
- 6. If the land is acquired by an abutting property owner(s), the bidder(s) must merge the parcel being acquired with their lot(s) prior to May 1<sup>st</sup>, 2022. - 7. The Town makes no express or implied warranties of any information contained herein. All parcels are sold without warranty as to suitability for building, the ability to gain any desired regulatory approval from the Town of Derry (e.g. zoning compliance and other state/local regulations), or the absence of any environmental hazard. Bidders are responsible for performing their own due diligence appropriate to the purchase of any real estate.
