Approval of Minutes:

Chair's Report, Correspondence & Bills:

Selt: Everlasting Newsletter: Shared with board.

Conservation Bylaws:

DCC Minutes March 6th, 2023

Commissioners were asked to review existing bylaws dated 2.20.17 and provide feedback for potential updates. Chair notes that any ratifications would need to be run by council.

Commentary from Commissioners for follow up and review:

Degnan: Need to meet at least once a month per bylaws.

Reisdorf: Confirm Charter Date we show on document is valid. 11/6/1984, Review membership requirements on other boards. Chair noted that we have a potential spot on EEAC.

Boonstra: Section 5 recording secretary requirement; chair working on.

Chabot: Under Article 4 add an official date of meeting in which we elect officers. Article 6 paragraph B add specific state RSA for appointing Conservation Commissions.

Reisdorf: Article 8 do we need to specify whom voted in the opposition. Discussion was that roll call vote would be unnecessary and we will continue current practice of YES and ABSTAIN.

Other Conservation Activities

Q1 Projects– Intro meeting for Website work complete. Communication to Rathburn for support unanswered. TRC meeting coming in April.

Low Property– Reported ATV abuse. Chair to walk with reporting party when they return to NH from vacation. Signs available to post.

House Bill #2 HB-655-FN: Repeal of RSA 310-A. Bill would remove ability for wetland scientists and soil scientists to be licensed and approved within NH and push for federal licensing. If this were to go through the federal group is not an official licensing board nor detailed to each regions needs including NH. Letter from DCC to be sent stating we do not support the passing of HB-655-FN. DES Likely opposes and NHACC officially opposes this action.

Chair notes need to go into Non Public Session; entering Non Public officially ends the meeting.

Adjournment: Bob Boonstra motions to enter Non Public Session per RSA 91A:3-11d Grace Reisdorf seconds. Roll Call vote. All vote yes. Non Public session starts.
