Minutes of Public Meeting May 9, 2016

On May 9, 2016, at 7:00 pm, the Derry Conservation Commission met in the 3rd floor meeting room of the Derry Municipal Center.

The following members were present: Chair, Neil Wetherbee, Ric Buzzanga, Eileen Chabot, James Degnan, Paul Dionne, Marius Zainea and Alternate Brian DeSimone. Council Liaison Charles Foote was present. Margaret Ives and Alternate, Peg Kinsella were absent. Brian DeSimone sat for Margaret Ives.

Acceptance of Minutes:

Ric Buzzanga made a motion to accept the minutes of April 25, 2016 with an amendment. Paul Dionne seconded the motion to approve with the amendment of (to pay a combined fee of up to \$100.00 for Derryfest booths for Go Green and DCC.) All others were in favor. Motion carried.

Chair's Report, Correspondence & Bills:

A "Wetlands Minimum Impact Forestry Notification" has been received from DES on Tax Map/Lot 14A & 11A/001 & 32. This was passed around.

The garden plots at Broadview will be staked off May 13th at 9:00 am.

Go Green:

Paul Dionne made a motion to pay \$140.00 to Flyer Communications for Go Green's website fees, to be taken from the Administrative account. Eileen Chabot seconded the motion. All others were in favor. Motion carried.

Chair, Neil Wetherbee will lead the Conservation walk at Cole Marsh, May 21st at 9:00 am. Meet at Damren Rd.

Other Business:

There was discussion at the previous DCC meeting on the amount to be paid to The South East Land Trust for their land protection efforts. The amount paid in 2015 was \$250.00. This year SELT is asking for \$500.00. DCC would like to keep this level funded. Paul Dionne made a motion to pay the South East

Land Trust \$250.00, to be taken from the Administrative account. Eileen Chabot seconded the motion. All were in favor. Motion carried.

Paul Dionne made a motion to enter into Non-public session per RSA 91-a:3ll(d)

Non-public meeting per RSA 91-A:3-II(d) "Consideration of the acquisition, sale, or lease of real or personal property which, if discussed in public, would likely benefit a party or parties whose interests are adverse to those of the general community."

Ric Buzzanga seconded the motion. All the members were polled and voted yes. Motion carried.

James Degnan made a motion to invite Town Council Liaison, Charles Foote to the non-public session. Paul Dionne seconded the motion. All others were polled and voted yes. Motion carried.

The meeting adjourned at 7:12 pm and the non-public session began.
