Minutes of Public Meeting June 13, 2016

Acceptance of Minutes:

Paul Dionne made a motion to accept the minutes of May 23, 2016 public meeting and the non-public minutes. James Degnan seconded the motion. All others were in favor. Motion carried.

Chair's Report, Correspondence & Bills:

Two Expedited Shoreland Applications have been received, which need to be viewed and signed by the Conservation Commission. The permits are for steps and wall repair at sites around Beaver Lake. Per Conservation Commission Policy, a couple of the commission members will need to do a site walk and view the plan, before the Chair can sign the plan. This will be done by Neil Wetherbee and Ric Buzzanga.

Paul Dionne made a motion to reimburse Neil Wetherbee \$98.00 for the garden stakes at Broadview. Ric Buzzanga seconded the motion. All were in favor the motion carried.
