Minutes of Public Meeting September 12, 2016

Go Green:

A request from Go Green was previously made for a laminated street map for use in marking off the streets during the Go Green Clean-up weeks. Doug Rathburn from the IT Department is printing the map.

Margaret Ives made a motion to spend up to \$50.00, to be taken from the Administrative account, for the lamination of the street map for Go Green. Ric Buzzanga seconded the motion. All were in favor. The motion carried.

Broadview Gardens - The cleanup date is November 1^{st.}

<u>Site Review:</u> Site Review - 7 Sheldon Road – 3 Lot Road Frontage Subdivision – Promised Land Survey. DCC has done a site walk. No issues were found. Paul Dionne made a motion for the Chair to sign the plan. James Degnan seconded the motion. Eileen Chabot and Margaret Ives abstained. All others were in favor. Motion carried.

<u>Site Review</u> - 154 Hampstead Road – 2 lot subdivision – Promised Land Survey- DCC has previously done a site walk. No issues were found. Paul Dionne made a motion for the Chair to sign the plan. James Degnan seconded the motion. Eileen Chabot and Margaret Ives Abstained. All others were in favor. Motion carried.

Other business:

A Land Steward Training program was suggested for October or November. A focal point would be determining boundaries. A separate workshop on this is a possibility.

Ric Buzzanga made a motion to spend up to \$75.00, to be taken from the Administrative account, to purchase (3) NHCC handbooks for the new DCC members. Paul Dionne seconded the motion. All were in favor. Motion carried.

The Alan Shepard Project Group would like to put a statue on the Shepard property. The property is a 35 acre parcel, which could have been 7 house lots, that was gifted to the town. The Derry Town Council is looking for feedback from the board on this. DCC members were asked to look over the Shepard Easement before the next Conservation meeting. There is some info in the easement agreement that no one member of the Shepard family would receive notoriety. Chair would like to have a spokesperson from the Shepard Project Group to come to the next DCC meeting.

Paul Dionne made a motion to enter into non-public session per RSA. James Degnan seconded the motion. All members were polled and voted yes. Motion carried.

James Degnan made a motion to invite Charles Foote, Council Liaison to the non-public. Margate Ives seconded the motion. All others were in favor motion carried.
