Minutes of Public Meeting October 26, 2015

On October 26, 2015 at 7:00 pm, the Derry Conservation Commission met in the 3rd floor meeting room of the Derry Municipal Center.

Acceptance of Minutes:

Paul Dionne made a motion to accept the minutes of October 19, 2015 with one change on page two under Gulf Rd. site review. Tim Winings should be stated as Robert Balquist. Eileen Chabot seconded the motion. Eileen Chabot moved to accept the minutes with the change. Paul Dionne seconded the motion. All were in favor. Motion carried.

Chair's Report, Correspondence & Bills:

The Go Green Movie showing "Bag It" will be held at The Coffee Factory, located in Hood Commons on November 21, 2015 at 6:00 pm. The movie is to encourage the public to pick up litter and dispose of it properly. The cost for Go Green to purchase the film was \$150.00. Liz Carver, Go Green Chair will have the invoice by the next DCC meeting November 9th.

Paul Dionne made a motion to pay \$150.00 to be taken from the Administrative account to pay for the movie "Bag it". Eileen Chabot seconded the motion. All were in favor. Motion carried. Alternate, Neil Wetherbee is now seated at 7:05 pm.

Broad View Gardens – The cleanup date is November 1, 2015. All fences, stakes and any thing that is not bio-degradable must be removed. The growing season was extra-long this year. There are still some hardy crops growing. The compost has been moved along through the bins.

Dredge & Fill:

19 Taylor Brook Lane — Tax Map/ Lot 18/029. A Shoreland Impact Permit application has been reviewed by DES. The proposal is to build a garage attached to the primary structure and to construct a second garage beyond the woodland buffer. The permit does not authorize the removal of any trees or saplings

within the waterfront buffer that would result in a tree and sapling point score below the minimum required per RSA 483-B-9.

Paul Dionne made a motion to pay \$750.00 to be taken from the Land Use account for the staking and flagging of Collette's Mountain, performed by Promised Land Survey. Peg Kinsella seconded the motion. All were in favor. Motion carried.

Quail Hill - Chair has been informed by a trail user that there is a tree down across the main trail which goes down to the rail trail. Peg Kinsella will check out the fallen tree. Downed trees being left to prevent ATV abuse to the trail was mentioned.
