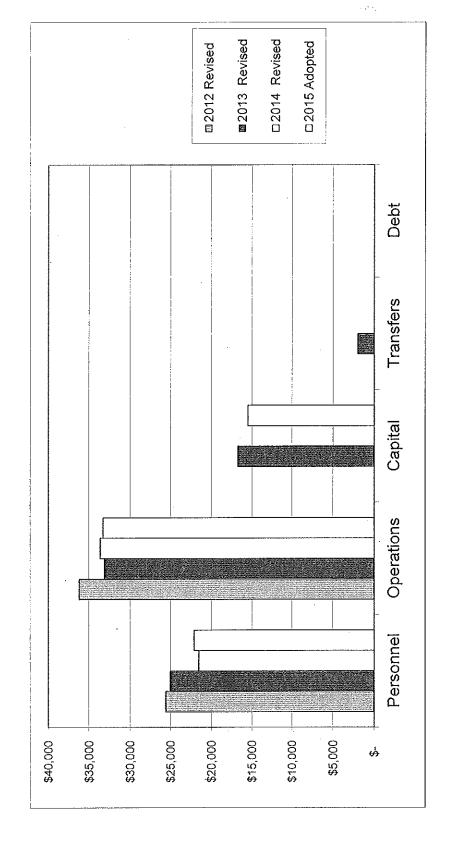

Department Mission and Objectives Fiscal Year 2015

DEPARTMENT: Emergency Management

Department Mission:

The Derry Bureau of Emergency Management (EM) leads the community effort to prepare the Town of Derry to effectively mitigate, prepare for, respond to, and recover from any natural or human-made disaster. Emergency Management assists other town departments in developing contingency emergency plans and maintains a comprehensive all hazards Emergency Operations Plan. EM serves as the coordinating agency among town departments and the conduit for communication with the NH Department of Homeland Security/Emergency Management during times of emergency and disasters.

EM maintains an Emergency Operations Center (EOC) which can be opened any day of the week, at any given time. The EOC is equipped with back-up power, computers, state of the art communication equipment and meeting space for emergency management personnel. The EOC has the ability to monitor weather conditions, communicate with the State of NH EOC, all town departments and area amateur radio operators. The EOC is also capable of broadcasting emergency information to the public through the internet, local cable television, Low Band AM Radio Station 1610 and an interactive automated telephone communication system (Code RedTM). The EOC coordinates resources, monitors conditions, and coordinates emergency shelter openings as required as well as coordinated emergency response between fire, police and public works.

The Bureau of EM employs a part-time person as the Assistant Emergency Manager to work with the community on establishing a number of programs including Storm Ready, preparing the citizens for emergency preparedness, coordinating the CERT and training all Town Staff in the Incident Command System and the Town's Emergency Operation Plan.

Department Objectives:

We shall:

- Minimize the loss of life and damage to property from fire through educating the public to prepare for possible natural or human made disasters. The Department will provide Public Information through the use of Derry CATV, local media and literature. During emergency incidents the Derry Bureau of Emergency Management will provide information to the public regarding pertinent local information including shelter information, road closures and emergency supplies.
- Develop a Continuation of Operations Plan (COOP) that will provides guidance to the Town of Derry and serves as the plan for maintaining essential functions and services during any catastrophic event. This plan will not replace nor supersedes\ the current

Emergency Operations Plan for the Town or any of the Departments, administrative regulations or standard operating guidelines; rather it supplements them, bridging the gap between the traditional, all-hazards planning and the specialized COOP planning required for a an unexpected event. This Plan emphasizes that maintaining essential functions during such an event and recognizes that relocation of personnel from one bureau, facility or work station may be necessary due to a separate or concurrent event.

- Continue to work with the local utility companies to develop plans that will assist the Town, its citizens and businesses during power disruptions. This will include but not be limited to coordinating the Towns GIS system with mapping and resources of the local utility companies. We will coordinate our efforts with the Regional Public Health Network to prepare to respond to individuals who are power dependent as a result of their medical status. The Bureau will develop a data input and retrieval system that will assist the Department to improve the effectiveness and efficiency responses
- ➤ Enhance short and long term plans for sheltering, warming and cooling station locations for Derry citizens. Develop a plan to increase our awareness and ability to respond to the at-risk population in Derry. This will include local as well as regional sheltering planning.
- In FY 2015 the Bureau will conduct training, including incident command training, and conduct table top drills with all Derry Department and Bureau heads to bring those employees that have responsibilities under the EOP into compliance with national recognized standards for emergency operations through the National Response Framework.
- Continue to enhance the local emergency notification system by purchasing an additional portable electronic reader board.

Programs and Activities:

Emergency Planning and Training: The Bureau continues to review and update the Derry Emergency Operations Plan. The Bureau is continuously reviewing and updating the Town of Derry Emergency Operations Plan and all its Emergency Support Functions (ESF). This is an on-going activity which involves bolstering of the Emergency Operations Plan (EOP) and developing policies and procedures to support it.

In 2014 the Bureau reviewed an updated the EOP and will review the EOP with each Department in the Town throughout 2015. The Emergency Management staff continues to coordinate efforts with all Town departments and has fostered a close cooperation with the Regional Public Health Network and the Medical Reserve Corps. (MRC).

In 2014 Emergency Management staff in collaboration with all other Town departments reviewed and updated the Town's Hazard Mitigation Plan as a part of the Towns long range planning efforts. These efforts were coordinated through a grant that was received by the Southern NH Planning Commission. In 2014 the Bureau finished completing the Storm Ready Plan and updated our storm emergency annex to the Plan.

Community Emergency Response Team (CERT): Beginning in 2008/9 the Bureau sponsored a CERT and has 14 active volunteers that have joined the group. The CERT meets monthly or more and has had a number of training exercises that will allow them

to participate in emergency as well as community events. The CERT has been unable to increase its membership during the past year. The CERT has increased its efforts to recruit and maintain membership. The Derry Cert has reached out to other emergency volunteer groups to coordinate efforts and investigate the possibility of consolidation. Though the size of the group has remained constant this group of volunteers has assisted the Town during last year's major power outages and at a number of functions including Derryfest, the Regional HEP C testing program, parking lot assistance at blood drives, and the Holiday parade to name a few. This group coordinates with the Town through the Assistant Emergency Manager who meets with them monthly for training and drills.

Community Notification Systems: The Bureau continues to use Code Red™ which is a web based community notification system and our low band AM radio station 1610 AM in that is used for local information and community notification. In the Bureau has made upgrades to the system by placing repeaters in Town in order to increase the clarity and effectiveness of the range of the radio station.

The Bureau in partnership with the Fire Department utilizes permanent reader and portable boards for a public notifications as well as emergency notifications. These signs have been an integral part of the community notification system and enhance the ability to notify the greatest number of residents and visitors throughout Derry.

The Bureau will continue to enhance and update emergency notification systems as well as continue to provide public safety training in order to keep our community safe and prepared
