Consent Agenda:

New Business:

The legislative update was given by John. Most bills were sent to interim study or tabled. HB 549 would take certain powers away from PUC and transfer them to the Department of Energy. Federal infrastructure money would provide \$1.7 million for EV charging systems statewide.

Jeff gave the update on EVCS planning. There hasn't been much status change on PUC fillings.

Mike gave an update on the landfill design status.

The town will receive \$500,000.00 infrastructure money for the landfill project which will reduce the price we pay for electricity to 6.1 cents per kilowatt-hour. The details still need to be worked out.

Craig gave an update on PR for the Solar Landfill project. We received good press in the Nuffield News, Clean Energy and other news organizations.

Jeff gave an update on the school infrastructure assessment. Some roofs are better than others. We are targeting two schools for solar panels. Jeff will meet with the school board for discussion.

Andrew gave an update on Pinkerton's solar project stating that any plans are in a holding pattern.

The committee finalized the goals for 2022 by voting 6-0 to accept. Andrew was not present for the vote.

The Derry Rotary club was looking for a speaker for Earth Day event.

Mike gave an LED update.
