Draft Minutes

Meeting called to order at 6:03

Consent Agenda:

Motion to approve minutes made by Mary Till and seconded by Brewster Bartlett. Motion passed 8-0- with Jess Ring abstaining.

New Business:

Election of officers:

Tom Cardon motioned to nominate Jeff Moulton as Chairman, motion was seconded by John O'Connor and passed 9-0.

Josh Bourdon nominated Craig Lazinsky as Vice Chairman, motion was seconded by Tom Cardon and passed 9-0.

Jeff Moulton nominated Tom Cardon Secretary, motion was seconded by Craig Lazinsky and passed 9-0

Ralph Meima, Director of Development for Green Lantern Solar gave a presentation on solar development. Green Lantern is a full energy developer working on net metering projects with different models. They are located in Waterbury Vermont.

Jeff and Mary gave an update on the EV Charging station at the Municipal Center. The Town Council voted to turn off the chargers while they review its status. The cost of the charging station has significantly increased due to a change in its billing class.

Jeff discussed Landfill Business Case & RFP and letter he sent to the Town Council. Josh and Jess will meet with school administration concerning their interest in joining this project. Jeff, Mike and Tom will meet with Mike Fowler to work on the RFP.

John O'Connor gave the legislative update. Discussed sb109 which has been tabled along with other energy bills as a negotiation tool. These bills will probably be brought back before July.

Craig gave an update on community power which has been challenging with Eversource.

Mike Fodiman gave a presentation Municipal Center's recent lighting change to LED lights.

Jeff informed the committee that the Fire Department has not engaged in energy initiatives for the four fire stations.

Motion to adjourn made by Brewster and seconded by Craig. Motion passed 9-0.
