The Planning Board for the Town of Derry will hold a public hearing to discuss proposed amendments to the following section of the Town of Derry Zoning Ordinance: Article V, Zoning Map and District Boundaries, Section 165-30, Zoning Map, to redistrict twenty-three (23) properties from the Traditional Business Overlay District to the Central Business District.
