SUBJECT:

Recruitment Process Psychological Testing Reimbursement

PURPOSE: Consider accepting funds from the State of New Hampshire, New Hampshire Police Standards and Training Council, to cover the cost for recruitment process psychological testing.

TOWN ADMINISTRATOR COMMENTS: The Council is urged to authorize staff to receive reimbursement for these expenses on an on-going basis to help defray local costs.

BACKGROUND: The New Hampshire Police Standards and Training Council has funds for reimbursing agencies for the cost of psychological testing in the recruitment process for police officers. By applying and providing proof of payment for our psychological testing, the Town of Derry would be reimbursed for up to \$750 dollars per examination. We typically see an expense of \$250 dollars for each psychological examination.

Derry PD has budgeted for the cost of the psychological examinations, so this would provide the town an offsetting revenue for this expense.

DISCUSSION: The Town Charter designates that the Town Council may apply for and accept grants or gifts. Specifically, "**SECTION 9.15 Grants, Gifts**; provides in part, that the Town Council may apply for, accept and expend monies received from the State, Federal, or other governmental units, or from private sources which become available during the fiscal year."

FISCAL IMPACT: The acceptance of these funds will provide the town with an offsetting revenue for a previously budgeted expense.

RECOMMENDED ACTION BY COUNCIL: Grant authority to the Town Administrator to regularly accept funds from the Police Standards and Training Council to offset the cost of psychological testing in the police recruitment process.
