SUBJECT:

Request for use of Capital Reserve funds for Fire Alarm System Replacement

PURPOSE: To be added to the Town Council agenda for the Tuesday, August 15th meeting to request the use of Capital Reserve Funds to pay for Johnson Controls to replace the malfunctioning fire alarm system at the Taylor Library. Asking for use of up to \$20,000 from the fund to cover the projected costs from the quote, plus possible wiring overages and annual monitoring fee.

TOWN ADMINISTRATOR COMMENTS:

The requested funds are to be sourced from the Taylor Library Capital Reserve Fund for essential repairs to the building. This request is crafted in the form of a Supplemental Resolution, as the original creation of the fund did not designate an Agent to Expend. To maintain consistency with other Capital Reserve Funds and to promote efficiencies, the attached Resolution also designates the Town Council as Agents to Expend to expedite future requests to use these funds.

BACKGROUND: There has been an ongoing issue with the fire alarm system at the Taylor Library. During the last test of the system, it was noted that it is not working properly and needs to be replaced.

DISCUSSION: The Board of Library Trustees has determined that the system needs to be replaced and the Library's Capital Reserve Fund, as established in 2001 is designed to support the physical facility.

FISCAL IMPACT: The Taylor Library Capital Reserve Fund maintains a balance in excess of \$342,000 and is adequately funded to support this request.
