**Update General Assistance Guidelines**

To update the Town's General Assistance Guidelines.

#### **BACKGROUND**

The Town has long adopted guidelines to assist the Town with processing requests for General Assistance. The Town previously relied upon two documents from the New Hampshire Municipal Association to guide its process, The Art of Welfare Administration (2016) and the New Hampshire Model Welfare Guidelines for Welfare Administrators (2012). The recommended changes in Resolution #2024-009 reflect updates to NHMA's Model Local Welfare Guidance (2021) and are recommended for adoption by our General Assistance Administrators, Community Health Services of Derry.

#### DISCUSSION

Periodically, changes in law and nomenclature require that the guidelines be updated. In addition, the guidelines should reflect current economic conditions thus, the allowances for items such as rental housing have been adjusted.

#### FISCAL IMPACT

It is anticipated that these changes will have some fiscal impact on the Town, although the precise amount is indeterminable, as it is reliant upon the caseload as managed by Community Health Services. The Town continues to have adequate capacity within its Human Services budget to absorb any cost increases.

#### RECOMMENDED ACTION BY COUNCIL & MOTION

Staff recommends that the Town Council approve Resolution #2024-009 to continue fair and equitable administration of the Town's General Assistance Program.
