SUBJECT:

Transfer of Funds for Software Purchases

**PURPOSE:** Consider utilizing the Police Detail Revolving Fund to cover the cost of software purchases for the Police Department.

**TOWN ADMINISTRATOR COMMENTS:** The Council is urged to support this request to use surplus funds to further support the accreditation program underway within the Police Department.

**BACKGROUND:** The Police Department seeks to purchase several different software platforms to enhance our daily operations and to comply with NH law enforcement accreditation standards. Utilizing revenue funds, we aim to offset the costs with the Police Detail Revolving Fund for the initial year's setup and implementation fees. A recent check of the balance for this account indicated we have \$258,975 available to us. Below is a list of software, descriptions, and costs. IT has agreed to add the yearly maintenance fees to their FY25 budget request.

#### **Watchguard Redaction Software**

This software will allow staff to efficiently redact audio/video evidence prior to release right here at the police department. We have a trial version of this software in use today and it is very effective. Previous to obtaining the trial version we relied on Derry Community Access Media to assist with the process of redacting video evidence. The finished product we get from DCAM, while functionally useful, was somewhat clunky and could lead a recipient to believe the video was altered to the point that we were trying to hide or alter the original video. The proposed software purchase alleviates that problem. This solution also provides a more efficient response time to RTK and discovery requests.

#### **Power Engage Community Engagement Software**

This software allows the police department to engage the community during our day-to-day functions. This is accomplished through obtaining surveys from residents after they have an interaction with DPD, communicating directly with citizens during an investigation they have filed, and even letting the reporting party know when police have arrived on scene of a call. This software would link with our CAD system to do so. Lastly, this would assist with accreditation requirements, which require having a system in place to receive feedback from citizens, etc.

#### **Guardian Tracking System**

Guardian Tracking Software is a tool that is used to track a variety of aspects of personnel management. These include use of force reports, performance evaluations, and the overall

well-being/mental health of our staff. Once built, this system would act as an early intervention program. NH accreditation standards require such a system.

### **Convey 911 Translation Software**

Recently, we were made aware that the DESC (E-911) will no longer provide language translation services for first response agencies unless there is an actual nexus to a 911 call. Up to this point we would simply call the E911 supervisor for whatever reason, when we needed language translation services, and it was provided. The costs incurred by the DESC, drive that decision to curtail the availability of that service. We have researched software options and discovered several agencies around us are using Convey911. This software will allow for direct translation, including American Sign Language via video, through our dispatch center, as well as a cell phone app, which would provide officers on the street with a tool for translation purposes. In addition to the cost noted above the company also charges a per minute fee for actual usage. The fees differ for telephone use, \$1.25/minute and a live video session via the app, \$2.25/minute.

**DISCUSSION:** Costs for the project are anticipated to be;

- Watchguard Redaction Software \$4,995
- Power Engage Community Engagement Software \$10,640
- Guardian Tracking System \$6,926
- Convey 911 Translation Software \$6,130

Total cost for 4 items - \$28,691

Does not include translation service use fees.

**FISCAL IMPACT:** All the funds needed to facilitate these purchases are requested from the Police Detail Revolving Fund. Those funds are not raised via tax dollars, but by a revenue stream from police details. The project, as laid out, will have no effect on the tax rate.

RECOMMENDED ACTION BY COUNCIL: Authorize the Town Administrator to expend funds from the Police Detail Revolving Fund to facilitate the acquisition of the software noted.
