SUBJECT:

Request to use Capital Reserve Funds for Chiller Compressor Replacement

INTRODUCTION: Seeking approval to fund replacement of the primary compressor for the Derry Public Library's chiller, which has failed, in the amount of \$10,075.00 from the Derry Public Library Capital Reserve fund.

TOWN ADMINISTRATOR COMMENTS

The requested funds are to be sourced from the Derry Public Library Capital Reserve Fund for essential building repairs. The Town Council is the Derry Public Library's Agent to Expend.

BACKGROUND

Recent maintenance to the Derry Public Library chiller has uncovered a failure of the unit's primary compressor. The compressor should be replaced ahead of the chiller being activated for the approaching warmer months. Not replacing the failed compressor in a timely manner increases the risk of cascading failures, and a full system failure. In either event, the library would be insufficiently climate-controlled through the warmest months of the year, and may need to close under certain conditions.

DISCUSSION

The Derry Public Library Board of Trustees has determined this repair is essential to avoid a system shutdown and the Library's Capital Reserve Fund, as established in 2004, is designed to support the building and its components. The Library's Finance Committee has reviewed three (3) quotes for the work, and requests release of funds in the amount of the lowest quote received.

FISCAL IMPACT

The Derry Public Library Capital Reserve Fund presently has a balance of approx. \$175,000 and is therefore adequately funded to support this request.

NOW, THEREFORE, BE IT RESOLVED IN COUNCIL, as Agents to Expend, that the sum of Ten Thousand Seventy-Five Dollars (\$10,075) shall be appropriated from the Derry Public Library Capital Reserve Fund to finance the replacement of the compressor.
