- Develop a vibrant and positive social media presence
- Work with stakeholders to update zoning to align with economic development
- Host signature events to put Derry on the map
- Create a vision on how to best position Derry for 4A



Efforts and Strategies to Achieve Goals

- Developed and distributed a town-wide survey
- Conducted a committee-driven SWOT Analysis
- Participated in several Planning Board workshops
- Hosted several business owner forums
- · Organized a restaurant/hospitality meet and greet
- Led a cross-marketing opportunity for Stockbridge Theater
- Recommended Facade Improvement Program
- Worked with Parks and Recreation to bring food trucks to the annual downtown trick or treat
- Established the first Economic Development Spring food truck event



Future of Derry EDAC

- Installation of a full-time Economic Development Director has changed the role of the committee and altered the involvement needed by committee members.
- Economic Development goals are now established by town staff. However, carrying out these goals requires dedicated committee members willing to volunteer their time.
- By establishing ad-hoc committees as defined in the EDAC By-Laws adopted in October of 2020, town staff will be provided with needed support and committee members will have a specific purpose.
- This new structure offers the opportunity to reenergize the committee and evolve with the economic landscape of the town.

- Created and implemented Temporary Outdoor Dining & Parklet programs
- · Coordinated physical inventory of Derry Businesses
- Created updatable business listing
- Boosts to Businesses: Small Business Saturday, Employee Recognition Program
- Assisted with grants for GDAC, PAC, assistance to businesses

Development Strategies

- Focus on Placemaking several PAC projects, Hood Park Ad-Hoc Committee. Hood Park improvement funding from Rec bond with potential funding from DCC TIF
- Collaboration with Planning on changes to CBD/TBOD/Industrial 4 and GC zones; Change of Use process
- Exit 4-A is back on track
