The Town of Derry, New Hampshire seeks proposals for:

## **Aggregated Electricity Supply**

The Town of Derry is seeking fixed price quotes for electricity supply for municipal and street lights.

#### Background:

The Town of Derry is currently receiving electrical supply through Constellation New Energy. The current contracts expire with the November 2019 meter reading. The Town of Derry seeks fixed cost supply for several Town owned facilities. Also, the Town is seeking fixed supply for streetlights in the Eversource franchise area.

### Scope of work:

The pricing shall be <u>FIXED</u> for the duration of the period requested:

1. 12 months through November 2020

The proposal shall include information relative to:

- Billing and payment terms
- Copy of sample or proposed contract
- Information relative to NHPUC Aggregator Registration
- History of other municipalities serviced by aggregator/generator
- Information on percentage of renewable energy from supplier
- Confirmation of Single Billing Format through Eversource

Upon request, The Town of Derry will allow account access through Eversource for use in furnishing a competitive bid. A copy of the EPO Energy Profiler request document and last month invoices are available for use by prospective vendors.

#### **Submission Information:**

Proposers must comply with the following submission procedures:

1. Sealed proposals shall be submitted marked "Aggregated Electricity Supply" on the outside of the envelope, addressed to:

Proposals will be accepted until 4:00 p.m. on **Wednesday, September 18, 2019**. Proposals received after this time will be returned unopened. Faxed or emailed proposals will not be accepted.

After review of all proposals, the Town of Derry will sign an agreement by no later than September 20, 2019, if the proposal is in the best interest of the Town.

- 2. AUTHORIZATION: The proposal must be signed in ink by an authorized signer, or by an agent of the proposer legally qualified and acceptable to the proposer, and contain the printed names, titles, and business and post office address of both parties, if applicable.
- 3. WITHDRAWAL OF PROPOSALS: A proposer will be permitted to withdraw their proposal unopened after it has been deposited if such request is received in writing prior to the time specified for opening of the proposals.
- 4. DISQUALIFICATIONS OF PROPOSERS: A proposer may be disqualified and the proposal rejected for either of the following reasons: 1) evidence of collusion among proposers or 2) failure to supply complete information as requested by this Request for Proposals.

- 5. RESERVATION OF RIGHTS: The Town of Derry reserves the right to reject any or all proposals, to waive technical or legal deficiencies, and to accept any proposal that it deems to be in the best interest of Town. Factors such as cost, service history, ease of billing format and renewable percentage shall be considered as part of the contract award.
- 6. SEPARABILITY The Town of Derry will accept only full packages for all requested elements. Proposals submitted without all scope of work items included shall be disqualified.
