Introduction

The Town of Derry Public Works Department is soliciting proposals from qualified vendors to perform trenchless sanitary sewer pipeline rehabilitation.

Proposals must be submitted on or before 2:00 pm – Friday, May 28, 2021 in a sealed envelope clearly marked as “Trenchless Sewer Pipeline Rehabilitation” and addressed to:

Proposals will be opened at the Public Works Office immediately following the closing.

Scope of Work

The work specified under this section provides for the rehabilitation of an existing sewer pipeline using the Cured-in-Place Pipe (CIPP) method equivalent to Permaliner CIPP Mainline Lining System. Proposals for equivalent Thermoformed PVC liner may be considered as well. The trenchless process consists of installing pipe liner inside an existing sewer (Host Pipe) from manhole to manhole. The CIPP pipe liner shall meet the requirements of ASTM F1216 or ASTM F-1871 for PVC. When installed, the liner will be a seamless, joint-less, solid wall liner that tightly conforms to the interior contours of the original host pipe. The liner shall be continuous from manhole to manhole with no seams or joints. Required service connections shall be reconnected using closed circuit television and remotely controlled cutters. The object is to restore the structural condition of the sewer and to eliminate infiltration from entering the lined section of sewer.

Sewer Pipeline Specifications

1. Location: Oak Street Derry, NH
2. Type: 8 inch VC Constructed 1958
3. Length: Oak St – SGM 528, 268 ft – 8” VC with 4 service laterals
Oak St – SGM 529, 273 ft – 8” VC with 6 service laterals
4. Condition:(See Attached Report) –CCTV Inspection available upon request.
5. Flow Rate: Low Flow.

Deliverables

The Contractor shall perform all work necessary to install the in-place liner, including but not limited to pre-cleaning, de-rooting, bypass pumping, and work zone traffic control. The Town desires a turnkey-style proposal.

Financial Considerations

1. All applicable taxes shall be indicated in the proposal.
2. The cost for traffic control, access, cleaning and inspection shall be included in the proposal price.
3. All costs for providing approved safe access in accordance with OSHA requirements shall be the responsibility of the contractor.
4. The contractor shall provide proof of insurance coverage and shall be included in the proposal cost. The successful bidder must provide the Town of Derry a certificate of Liability Insurance of no less than one million dollars (\$1,000,000.00) The successful bidder must provide a certificate of insurance for Workers' Compensation as required by New Hampshire Revised Statutes Annotated (NHRSA) 281-A.
5. Proposals shall include costs for any travel, meals and accommodations.
6. Terms of Payment – The Town of Derry agrees to pay full invoiced amount within 30 days following completions of the work and receipt of all reports.

Vendor Response

1. Proposals must contain an Executive Summary, which shall contain:
 - A brief description of the means and methods of access and installation.
 - The name, title and address of the Contractor's representative responsible for the preparation of the proposal.
2. All prices quoted for goods and services must be specified. All proposals will be held to be valid for ninety (90) days following the proposal closing date.
3. Proposals must be received in full on or before the exact closing time and date indicated. Proposals received after that date may not be considered.
4. All costs relating to the work and materials supplied by the contractor in responding to this RFP must be borne by the Contractor.

Product History and Contractor Reputation

The vendor shall provide a list of three (3) organizations where similar work has been performed. Include a contact person for each organization.

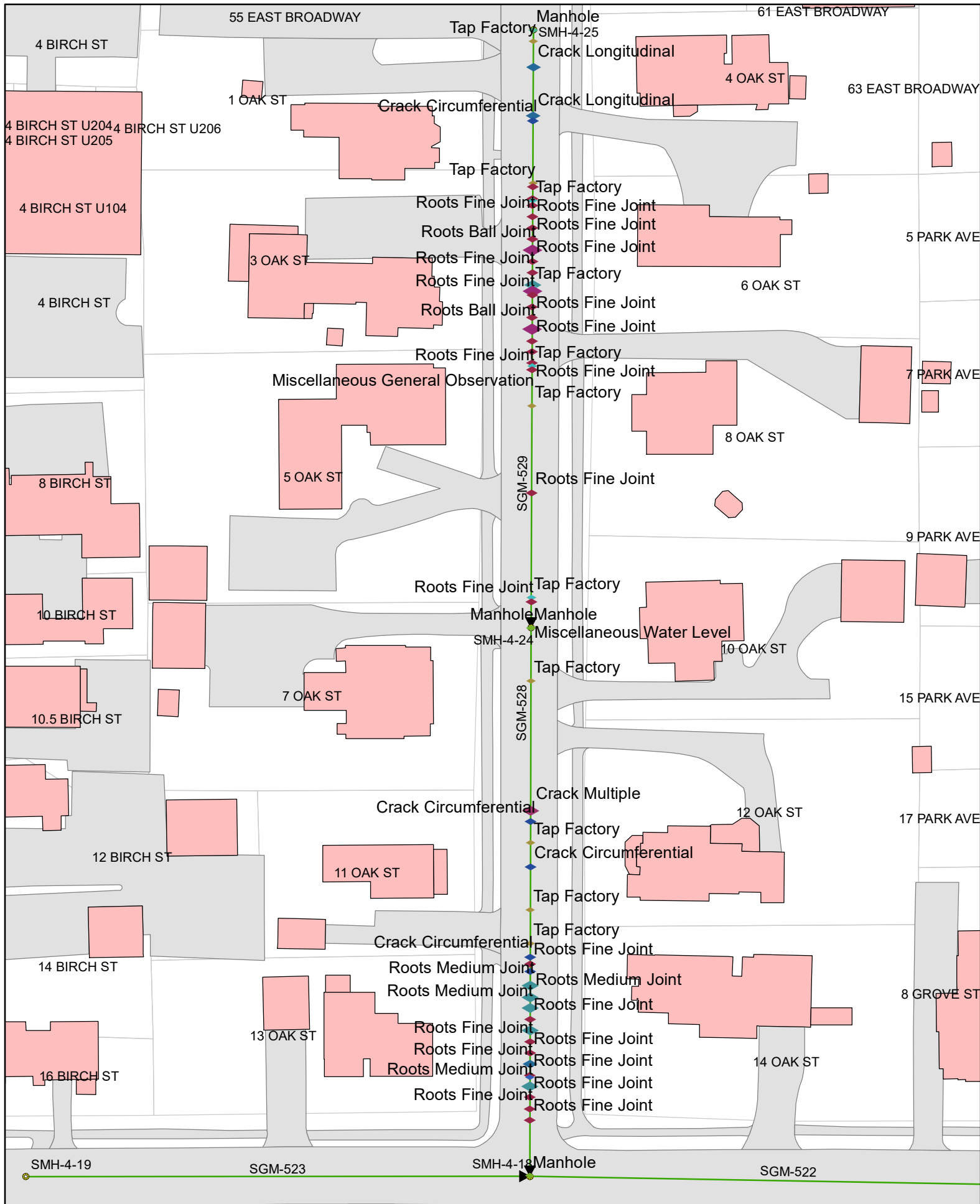

1. The proposals shall be opened at the Derry Public Works Department on the date and time as indicated on the request for proposal covering.
2. Any proposal may be accepted in whole or in part. The lowest proposal may not necessarily be accepted and the Town of Derry reserves the right to cancel the RFP call. The Town of Derry shall not be held responsible or liable for the payment of any costs that are incurred by the bidder in preparing a proposal in response to this RFP.
