Separate sealed BIDS for the construction of: **Influent Pump Station Wet Pit Improvements** will be received by THE TOWN OF DERRY at the office of TOWN OF DERRY until 2:00 PM. Local Time on **Thursday, December 7, 2023**, and then at said office publicly opened and read aloud.

1. Completion time for the project will be calculated as calendar days from the date specified in the "Notice to Proceed" as follows:

300 calendar days for substantial completion.

330 calendar days for final completion

Liquidated damages will be in the amount of \$1,000.00, for each calendar day of delay from the date established for substantial completion, and \$1,000.00 for each calendar day of delay from the date established for final completion.

2. Each General Bid shall be accompanied by a Bid Security in the amount of 5% of the Total Bid Price.
3. The successful Bidder must furnish 100% Performance and Payment Bonds and will be required to execute the Contract Agreement within 10 days following notification of the acceptance of their Bid.
4. Any contract or contracts awarded under this Advertisement for Bids are expected to be funded in whole or in part by: **(Select all appropriate.)**
