Separate sealed BIDS for the construction of the Southern NH Regional Water Project, Contract D1 – Route 28 Water Main including approximately 7,600 LF of 16-inch diameter water main and a pressure reducing valve station.

1. Completion time for the project will be calculated as calendar days from the date specified in the “Notice to Proceed” as follows:

<u>280</u>	calendar days for substantial completion. (No later than June 15, 2020)
<u>310</u>	calendar days for final completion.

Liquidated damages will be in the amount of \$ 1,000.00 for each calendar day of delay from the date established for substantial completion, and \$ 500.00 for each calendar day of delay from the date established for final completion.

2. Each General Bid shall be accompanied by a Bid Security in the amount of 5% of the Total Bid Price.
3. The successful Bidder must furnish 100% Performance and Payment Bonds, and will be required to execute the Contract Agreement within 10 days following notification of the acceptance of his Bid.

4. Any contract or contracts awarded under this Advertisement for Bids are expected to be funded in whole or in part by:
 - A grant from the NH Drinking Water Groundwater Trust Fund
5. No Bidder may withdraw a Bid within sixty (60) days after the actual date of opening thereof.
6. There will be a **non-mandatory pre-bid meeting** at the Town Municipal Center (14 Manning Street) at **10 am on July 9** for all prospective bidders. Representatives of the Owner and Engineer will be present to discuss the project.
