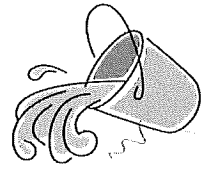

All groups and organizations interested in visiting Don Ball Park must complete and submit this Group Application AND receive confirmation from the Recreation Office. Upon receipt of the forms, groups/organizations will be permitted to attend based on availability, receipt of payment, and the adherence to all rules and guidelines. The playground and splashpad equipment is not sanitized. **The water features are scheduled to be on, weather permitting, mid-June through Labor Day. There is no guarantee that the Splashpad water features will be on and functional during your scheduled visit. Group visits begin June 19, 2023.**

Please initial that you agree to the following:

- All groups of 10 or more (including participants and chaperones) must pre-register and pre-pay at least two weeks prior to their reservation or will be removed from the reservation list.
- Derry resident-based groups are free of charge. Non-resident based groups incur a \$100.00 per visit fee
- Groups can only visit Don Ball Park on Mondays, Tuesdays, and Wednesdays, 12:00pm – 4:00pm.
- There is a daily limit of 80 children, comprised from any combination of pre-registered groups that will be accepted on any given Group Day.
- All busses are to park, unload, and load in the designated bus parking area. (Map online is available)
- There is a maximum of 1:8 chaperone to child ratio.
- Each group is limited to three visits per month.
- Group Leaders are to check-in at the concession stand onsite and wait for permission from a site supervisor to unload the bus/vehicles at Don Ball Park.

In the event of inclement weather or unforeseen circumstances, the Department reserves the right to close the Splashpad and/or Don Ball Park. Groups are not permitted to use the ball fields without prior authorization which includes additional permitting. The park and Splashpad are open to the general public during operational hours. Your reservation does not secure exclusivity to the park. Picnic tables, benches, etc. may not be reserved. I have read through the Splash Pad and Park Policies and will ensure that the entire group follows all rules, regulations, and guidelines set forth by this policy as well as all other state and municipal regulations/laws/policies. Any group that does not abide by the Department policies, regulations, and/or guidelines will be instructed to leave the premises and may not return at a future date.
