No contested hearings were held.

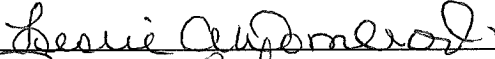

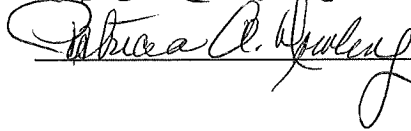
