Chairman Report - Charles Foote

Boston Post Cane Presentation – Karen Blandford-Anderson, Heritage Commission Chair presenting

The Boston Post Cane program, with its rich history dating back to 1909, was initiated by the Boston Post Newspaper. The newspaper distributed these canes to towns across New England as a way to recognize and honor the oldest living resident in each town. The 2023 Boston Post Cane Nominee is Lois Palmer Rae. Mrs. Rae was born on August 21, 1926, in Mine Hill Township, New Jersey. Mrs. Rae and her family moved to Derry in 1973 and have lived on Chester Road since then.

Town Administrator's Report - Dave Caron

After completion of the first quarter of FY24, we have not identified any problematic areas with revenues. The Town expects to exceed its revenue estimate for earnings on investments when the September returns are calculated. The Town recently signed its first construction contract associated with the Central Fire Station project. American Excavating will be completing the site work for the project and will commence operations within the next few weeks. The project budget will be submitted once received from the Architect/Construction Advisor. The US Department of Energy has completed its review and awarded the grant to assist with the construction of the solar field at the closed landfill. We now await Eversource's review of the interconnection in order to proceed with the project. This grant will drop the project's 25-year fixed electricity rate from 6.8 cents to 6.0 cents per kWh.

As you may have heard, HCA, owner if Parkland Hospital, is in discussions with Catholic Medical Center to purchase that facility. We've had discussions with Parkland management about this, and don't anticipate many operational changes at Parkland, except for critical care transfers, which may be directed towards CMC vs Portsmouth Regional Hospital, a benefit for patients and families. The proposed acquisition is under regulatory review and may occur in the next 9-18 months.

New Business

23-115 Resolution #2023-074 – Direct Tax Collector not to execute certain Tax Deeds – *Tax Collector Stacey Beliveau presenting.*

On April 13, 2021, the unpaid balances of the 2020 tax bills were liened at the Rockingham County Registry of Deeds. According to RSA 80:76, "the collector, after 2 years from the execution of the real estate tax lien, shall execute to the lienholder a deed of the land subject to the real estate tax lien and not redeemed." RSA 80:76 also provides the Town Council specific and subjective reasons to waive tax deeding. At this time there are no properties subject to the issuance of a Tax Collector's Deed currently. There are 13 properties not recommended for deeding. These properties are recommended for waivers due to potential liability risk or undesirable obligations. While this will mean a delay in payment and deeding of these properties, the should be recoverable at a later date.

23-116 Resolution #2023-075 – Authorize use of Dominion ImageCast Precinct Electronic Ballot Counting Devices – *Town Clerk Tina Guilford presenting.*

The Ballot Law Commission approved two devices for the electronic counting of ballots on September 15, 2023. After a full review of both of the approved devices, the ImageCast device is the one that has been chosen for use in Derry. LHS has been a very responsive partner over the years. They are local, in Salem NH, and we have the ability to drop off and pick up our programming cards for elections. The ImageCast is also very similar to our current AccuVote machine and will be simple for voters to use.

Transfer Funds from the Derry Recovery Expendable Trust Fund

WHEREAS, Section 9.7 of the Town Charter empowers the Town Council to transfer any unencumbered appropriation balance; and

WHEREAS, the Town Council pursuant to Resolution #2021-025 created an Expendable Trust for the Derry Recovery Plan to receive funds from the American Rescue Plan Act and disburse as necessary; and

WHEREAS, the Town Council pursuant to Resolution #2023-075 has authorized the use of Dominion ImageCast Precinct Ballot-Counting Devices for elections in Derry; and

WHEREAS, funds are available in the Derry Recovery Expendable Trust Fund (ARPA) to purchase counting devices necessary to conduct elections in Derry.

NOW, THEREFORE, BE IT RESOLVED IN COUNCIL that the Town Administrator is authorized to transfer the sum of Fifty Thousand Four Hundred Dollars (\$50,400) from the Derry Recovery Expendable Trust Fund to purchase eight Dominion ImageCast Precinct Ballot Counting Devices.

Number 2023-074

To Direct the Tax Collector not to Execute Certain Tax Deeds

WHEREAS, Section 5.1 of the Town Charter establishes the Town Council as the legislative and governing body of the Town; and

WHEREAS, RSA 80:76 sets forth the procedure for conveying tax deeded properties to the Town; and

WHEREAS, pursuant to RSA 80:76 II and II-a, the Governing Body may refuse to accept a deed on certain properties, whenever in its judgment acceptance and ownership of those properties would subject the municipality to undesirable obligations or liability risks; and

WHEREAS, the Town has identified properties eligible for tax deed however acceptance of ownership would not be in the Town's best interest;

NOW, THEREFORE, BE IT RESOLVED that the Tax Collector is hereby directed not to execute a tax deed as set forth on the attached list; pursuant to RSA 80:76 III, the Council may revisit this decision at any time and may later direct the Tax Collector to issue a deed for the property subject to this directive.

To Authorize the Use of Dominion ImageCast Precinct Electronic **Ballot-Counting Devices**

WHEREAS, Section 5.1 of the Town Charter designates the Town Council as the governing and legislative body of the Town; and

NOW, THEREFORE, BE IT RESOLVED IN COUNCIL that the Town Council pursuant to RSA 656:40 hereby authorizes the use of Dominion ImageCast Precinct Electronic Ballot-Counting Devices for all elections in Derry conducted on or after March 1, 2024.
