

Town Administrator's Report – Dave Caron

Landfill Solar Update - Director of Public Works Mike Fowler

This is just an update on the landfill project. We are moving forward with Encore Renewable Energy. We are at the end of the permitting process. Rob Greer and Katie Hinds are here with an update on the construction phase. We look forward to starting actual construction in May. The lease agreement, power purchase agreement, some additional costs. We will be transparent about the costs.

The Town Council will meet in non-public session on Wednesday, January 10 @ 4:30PM to discuss the sale of real estate.

The CFO has recently opened the budgeting portal for Departments to begin working on the FY25 budget process. The Capital Improvements Program for FY 25-30 is also underway; we expect the draft plan to be presented to Council in February as an FYI, as we will be presenting to the planning board as well during February for their comments and input. We would also request input on the budget review schedule as the room is now reserved for the School Board on the 2nd and 4th Tuesdays. Options may include lengthening the available dates to include more departments or scheduling a Saturday workshop.

Tina has been tracking legislation which may impact municipal interests and we'll be presenting information to the Council throughout the session seeking input or requesting a Council position on some of the issues.

WHEREAS, the Town Council pursuant to Resolution #2022-022 funded repairs to the Wastewater Treatment Plant's main influent pumping station; and

WHEREAS, the Town recently received bids to complete this work, which bid exceed the funds previously appropriated; and

WHEREAS, the ARPA Grant anticipated through the State Department of Environmental Services was slightly less than budgeted; and

WHEREAS, the Town's Wastewater Fund has an adequate fund balance from which resources which re

NOW, THEREFORE, BE IT RESOLVED IN COUNCIL that the sum of One Hundred Fourteen Thousand Four Hundred Thirty-Four Dollars (\$114,434) shall be appropriated from the Wastewater Fund Balance for this project.

This Resolution has been adopted by two-thirds majority of the entire Council as required by Charter and shall take effect immediately upon its passage.

Transfer Funds from the Highway Division Bridge Fund

WHEREAS, Section 9.7 of the Town Charter empowers the Town Council to transfer any unencumbered appropriation balance; and

WHEREAS, the Town maintains a Highway Division Bridge Fund in which funds previously appropriated by the Council or accepted from outside sources are deposited; and
