Chairman's Report – James Morgan

Town Moderator Mary Till presented information regarding the March 12, 2019 Town and School Election. The polls will open at 7am and close at 8pm. Districts 1 & 4 will vote at Gilbert H. Hood Middle School and Districts 2 & 3 will vote at West Running Brook Middle School. The moderator's rules will be distributed to all the candidates and voters can look up what they are voting on and what district they are in on the town website.

Requested that the appointment of he Derry Housing & Redevelopment Authority member be postponed until the next meeting in the event that there are new councilors elected.

Town Administrator's Report - David Caron

Human Resources Director Bill Scimone is retiring effective Thursday. The Town has received 44 resumes for the position and the top candidates have been interviewed. A recommendation will be made to the Council at the March 19th meeting and a confirmation by the council will be required. The Town Administrator met with representatives from the Center for Life Management and Community Health Services and they both are continuing to review applications and have a budgeted amount available of \$89,000. The Conservation Commission has been working on an easement on Lane Road and the authorization will come before the council. The Planning Board is scheduled another public forum on the Master plan. It is scheduled for Saturday April 6th from 10:30am to 12:30pm in the 3rd floor meeting room. The Age-Friendly survey results are posted on the town website.

New Business

19-16 Resolution 2019-006 Establish a Derry Cultural District – *Economic Development Director Bev Donovan, Cable Division Coordinator Owen Provencher, and President of the Greater Derry Arts Council Mike Gendron*

The Greater Derry Arts Council & GDAC Public Arts Committee recognizes the importance of Art & Culture to provide vibrancy and enhance the experiences of residents, visitors, and businesses and further seeks to support the goals of the Town Council to enhance potential economic development efforts in the Town of Derry. As such, the GDAC is proposing a formal Cultural District as an aid to the shared effort of preserving, promoting and encouraging arts and culture to strengthen the community and stimulate the local economy. The State of NH has recognized that support for arts and culture is important to overall desirability of living and working in NH, and Governor Sununu has recently appointed Commissioner Sarah Stewart to oversee the new Department of Natural and Cultural Resources to leverage NH's unique assets. The GDAC recognizes this important gesture and agrees that arts and culture in NH, and locally in Derry, is important to economic stability.

19-17 Resolution 2019-007 To Enter into a Lease-Purchase Agreement for Police Equipment – *Police Chief Ed Garone and Police Captain George Feole*Included in the FY19 budget is an approved expenditure of funds from the capital reserve account to purchase replacement Tasers. During efforts to facilitate that purchase, pricing options were sought from Axon, the company that manufactures and markets the Tasers. It was discovered that it is more fiscally prudent to enter into a 0% 5-year lease purchase arrangement with the company than it is to purchase the equipment outright. A straight purchase of 61 Tasers would cost \$98,810, the 5-year lease option for 61 tasers provides for 5 annual payments totaling \$87,600. 60 additional duty cartridges are included over the term of the lease at no additional cost. Because there is a 0% lease rate, duty cartridges are included and discounts are applied via the lease, there is a savings of \$11,210 by leasing vs a straight purchase. The 5 annual payments, \$17,760 in year one and \$17,460 in years 2-5 will be drawn from the capital reserve account negating any tax impact.

RESOLUTION

Number 2019-007

To Authorize a Lease/Purchase Agreement to Finance the Acquisition of Police Department Tasers

WHEREAS, Section 7.1 of the Town Charter designates the Town Council as the Legislative Body of the Town, which is then empowered by New Hampshire law to incur obligations on behalf of the Town; and

WHEREAS, the Fiscal Year 2019 Town Budget included funds for the purchase of replacement Tasers for the Police Department; and

WHEREAS, after negotiations it is in the Town's best financial interest to enter into a zero-interest lease-purchase agreement to acquire the Tasers;

NOW, THEREFORE, BE IT RESOLVED IN COUNCIL that the Town Administrator is hereby authorized to enter into Lease/Purchase Agreement with Axon Enterprises, which will include a fiscal funding clause;

Further, that this authorization shall not increase appropriations beyond what has been previously authorized under separate Council action and to take such other actions as may be necessary to consummate such financing.
