# Town Administrator's Report - Stephen Daly

Thanked the councilors that attended the swearing in of the new police officers last Friday. He stated that there is an application for a license for a public gathering for the area to the west of Halligan's Tavern. The applicants would like the street closed off May 25<sup>th</sup>. It is a fundraiser for a former Derry Firefighter diagnosed with Leukemia.

# **New Business**

**16-67** Presentation on Amendment #7 to Exit 4A Environmental Impact Statement Engineering Contract

A supplemental appropriation is requested to proceed with engineering work associated with the Environmental Impact Statement for Exit 4A. On July 15, 2014 the paradigm of the Exit 4A project changed when the former NHDOT Commissioner Christopher Clement expressed to the Derry Town Council that NHDOT would serve as project sponsor and seek federal funds for construction of the new interchange and collector roads. NHDOT has included the construction of Exit 4A in its draft 10-year plan, to be completed by 2022. NHDOT and the two Towns worked to negotiate a scope and fee agreement with CLD in the amount of \$2,333,197, with Derry's 50% share of the cost being \$1,116,598. Amendment #7 will finalize the EIS document for submission to FHWA. The Exit 4A agreement obligates Derry to expend \$5,000,000 as its share of the total project cost. The completion of EIS would be done by the end of 2017, the record of decision by early to mid-2018, the preliminary engineering by 2018-2019, the right of way 2019-2020 and construction in 2020.

**16-68** Presentation on U.S. Dept. of Justice Bulletproof Vest Grant Program

Chief Garone presented the request for bulletproof vests. The Derry Police department was notified by the Bureau of Justice Assistance (BJA) that the Derry Police department is eligible to receive an award under the Fiscal Year 2016 Bulletproof Vest Partnership (BVP) program. The funds can be used until August 31, 2018. It is projected that the Derry Police department will need twelve bulletproof vests. The BJA would reimburse the police department for 50% of each

vest after the purchase has been made. The vests have a 5 year lifespan and if approved, it would be included in the FY2018 budget. The police department has 8 included in the current budget.

Planning Director George Sioras presented the proposed amendment to Zoning Ordinance Article V. Three property owners on Lenox Ave across from Walgreens and adjacent to Sal's Pizza would like their zoning designation changed from Medium High Density Residential (MHDR) to General Commercial (GC). New development and redevelopment of commercially zoned parcels will expand the town's tax base and present opportunities for new business and employment.

CFO Susan Hickey and Acting Town Administrator Stephen Daly make a presentation on the items the councilor's flagged during the budget workshop and the items that the councilors requested more information on. The council question if most town employees are receiving longevity pay and are told yes. The council is informed that the Derry Firefighters receive hours off but they are based on a 24 hour day. The council would like short term disability and workers compensation to be bid out.

Line 390 totaling \$65,000 will be removed to get to the 1 cent reduction goal. The goal of this council is to provide services but still lower the tax rate. There are bonds that are going to be retired, contracts that can be renegotiated, and more items bid out. The capital reserve will be funded adequately.

# RESOLUTION

# Number 2016-009

To Authorize Application for and Expenditure of Grant Proceeds to Fund Acquisition of Protective Vests for Police Personnel

WHEREAS, the Town Charter establishes the Town Council as the appropriating authority of the Town and in that the expenditure of grant funds is authorized by way of appropriation; and

WHEREAS, grant funding is available to law enforcement agencies through the U.S. Department of Justice, Bureau of Justice Assistance, Bulletproof Vest Partnership Program, under which the Derry Police Department is eligible; and

WHEREAS, periodic replacement of bulletproof vests is essential to the safety of police personnel and has been budgeted for in the FY2016 operating budget; and

NOW, THEREFORE, BE IT RESOLVED IN COUNCIL that the Town Administrator is hereby authorized to apply for grant funding in the amount of Six Thousand One Hundred Thirty-two and 00/100 Dollars (\$6,132.00), that being the sum the Derry Police Department is eligible to receive, and furthermore, to accept award of that or any larger sum and to expend such funds upon their receipt.

This Resolution shall take effect immediately upon its passage.
